

POLICY STATEMENT: Discrimination is against the law.

PROCEDURES:

1. Hospice Home Care (HHC) complies with applicable Federal civil rights laws and does not discriminate on the basis of race, color, national origin, age, disability, or sex. HHC does not exclude people or treat them differently because of race, color, national origin, age, disability, or sex.
2. Hospice Home Care:
 - a. Provides free aids and services to people with disability to communicate effectively with us, such as:
